## Report of the Programme dated 1st July, 2023

The Maharashtra State Human Rights Commission in collaboration with DSLA Mumbai Suburban, and the Charity Commission of Maharashtra, provided a total scholarship of ₹7,50,000/- to 75 adopted disabled persons with the support of HETU Charitable Trust, Mumbai.

This program was organized on Saturday, 1<sup>st</sup> July, 2023 at ASPEE Auditorium, Malad West. It was honoured with presence of the chief guest of the program, Justice Kamal Khata of Bombay High Court, and Justice Sandeep Marne of Bombay High Court. Justice KK Tated, Chairman, Maharashtra State Human Rights Commission and M.A. Sayeed, Member, Maharashtra State Human Rights Commission has also honoured the programme. Mr. M. K. Mahajan, Charity Commissioner, Maharashtra was also honoured the dais. Chairman of JITO Apex, Mr. Nahar was also one of the dignities on the occasion.

In the programme, Trustee of HETU Mr. Rikhab Jain said that the adoption scheme has been started by said NGO for last 12 years. Every year 40 disabled children be benefited of the adoption scheme. This year on Amrit Mahotsav of the independence, 75 Children have been adopted and supported with scholarship. Happy families take care of the needs of specially abled children.

The chief guest of the program, Justice Kamal Khata of Mumbai High Court, said that I am happy to be present in the program and to do the noble work. Justice Sandeep Marane of Bombay High Court said that we have received a PIL that there is difficulty for disabled in identifying present currency notes and finding the way out to this difficulty.

Charity commissioner Mr. M. K. Mahajan said that there are more than 9 lakh trusts registered in the Maharashtra state and all are making continuous efforts for the betterment of the society. Mr. M. A. Sayeed, a member of the MSHRC, has apricated the work of HETU Trust. Justice K. K. Tated, Chairperson of

MSHRC has acknowledged the work of HETU towards the humanity, specially to the children with challenges.

Mr. Sanjay Kadam, Deputy Commissioner, Divyan Kalyan Ayuktalaya, Pune introduces various schemes available to the special-abled persons in Maharashtra. He has also represented Divyang Kalyan Vibhag, as the concern Secretary was unable to attend the function.

Saksham Konkan Province is another NGO, benefited by the event. The President of said NGO Mr. Ramesh Sawant who is 100% visually challenged, also appreciated work of HETU. He said that disabled students who get help, they will help others in future, then the intention of the organization will be considered meaningful.

Chairman of JITO Mr. Nahar praised the trends of the trust and said that they are adopting 11 specially abled children this year and 100 specially abled children will be adopted in upcoming years.
