- 1) The Maharashtra State Human Rights Commission held Medical Camp by Gynecologist & Dermatologist in association with Mumbai Suburban DSLA and Jain Doctor's Federation, Bombay on 16.04.2023 at 10.00 a.m. for inmates of Home for Mentally Deficient Children, Opp. BARC Bus Depot, V.N. Purav Marg, Mankhurd, Mumbai 400 008. At that time on behalf of Maharashtra State Human Rights Commission, the following persons were present:

- 3) From Home for Mentally Deficient Children following persons were present including their staff:

- 4) At 10.00 a.m. the Medical camp started. Same was divided into two parts (i) inmates those who require dermatologist service and (ii) inmates those who require gynecologist service.
- 5) The said camp was continued till 2.00 p.m. In that more than 60 inmates were examined and gynecology. Further action was prescribed by the Gynecologists.
- 6) In similar way Dermatologist examined more than 40 inmates and prescribed their line of treatment.
- 7) During this period, Hon'ble Chairperson, Hon'ble Member along with Registrar of Maharashtra State Human Rights Commission taken round and inspected the entire area. The said

complex is situated in more than 45 acres of land. Out of that near about 25% of the land is encroached by the third party. In Commission's visit, Commission noticed that some of the premises are not maintained properly, they are in dilapidated conditions. Even the structural report is not carried out for last more than 20 years. Except some premises which are recently constructed, other premises are required either re-construction and or extensive repairs. During the visit Commission directed the officer in charge to prepare a report on several points and submit before this Commission within two weeks i.e. on or before 21.04.2023.

- 8) During the visit some photographs are also taken showing the present conditions of the structures.
- 9) In the above mentioned facts it is crystal clear that the said institution is required immediate help from the concerned Government Department. Even to maintain law and order in the premises they require some Police protection also.
- 10) Therefore, Commission decided to take up this issue by way of Suo Moto complaint.
- 11) A copy of investigation is enclosed herewith.
