ORDER

- 1. It seems that the officers of the Maharashtra State Electricity Distribution Company Limited could not get themselves connected because of weak range. Ld. Advocate Shri. Jinsiwale for Maharashtra State Electricity Distribution Company Limited is present and he tenders additional documents. Those are accepted on record.
- 2. This complaint came to be registered as suo moto on the basis of newspaper report which is to the effect that a father and son named Kakasaheb Daulat Shikare and Mahesh Kakasaheb Shikhare died because of electric shock from the broken electric supply line. This accident took place in the agricultural field.
- 3. Advocate Sandeep Jinsiale appearing for the Maharashtra State Electricity Distribution Company Limited submits that in such fatal accident, the electric supply company pays a

compensation of Rs. 4,00,000/- to the next of kin of the deceased and in the instant case compensation totaling Rs. 8,00,000/- has been paid to the next of kin of both deceased.

- Shri Rajput, Asst. Police Inspector submits that crime is 4. under investigation and it will be taken to logical end.
- That apart record shows that concerned employee of the 5. distribution company is being proceeded departmentally also.
- In this view of the matter as the next of kin of the both deceased are adequately compensated, hence, the suo moto complaint is closed.
