ORDER

1. Shri. Rahul Shrirame, Dy. Commissioner of Police, Maharashtra State Security Corporation is present. Shri. S G Aagvane, Joint Director is present. Shri. Ananda Jadhav, S.S.O is present. Advocate G H Mohanty is present.
2. This proceeding was initiated by taking suo moto cognizance on the basis of the clip circulated in the social media wherein the employees of Maharashtra State Security Corporation were ^{allegedly} indulged in extraction of money near the tunnel at Khalapur by stopping vehicles.
3. In response to the notice issued by the Commission Shri Rahul Shrirame, Dy. Commissioner of Police has filed his affidavit. He had conducted fact finding inquiry and has found no substance in the clip which was being circulated in the social media. His inquiry reveals that the employees of the Corporation were managing the traffic which was obstructed by the

breakdown of the vehicle in the tunnel. Even the person who has recorded the video has accepted the fact that there was no demand of the money by the employees of the said Corporation. That apart for lapses in working of the concerned employees necessary action is taken by the Corporation and order to that effect is placed on record.

4. So far as powers of the employees of the Corporation is concerned, my attention is drawn to the Section 16, 17 and 18 of the Maharashtra State Security Corporation Act, 2010 which ⁿ ~~explicitly~~ ^{explicitly} ~~exclusively~~ provides that the employee shall be deemed to be the special Police Officers within the meaning of the term under ^{the} Maharashtra Police Act. They are public servant and can exercise power of arrest under the relevant procedural ^{code} code.

5. In this view of the matter the suo moto proceeding are dropped and closed accordingly.

6. Inform to all the parties concerned.
