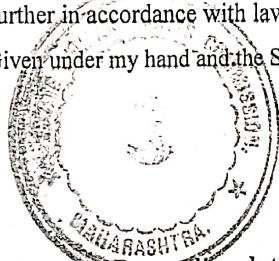

PROCEEDING

1. Perused the newspaper report dated 27.07.2025 from various Dally newspapers. It is averred therein that because of open chamber in the Maharashtra Industrial Development Corporation area of Kalyan Dombivili Municipal Corporation, one precious human life is lost. Babu Chavan who was walking near Tata Power Naka area had suffered a fall inside the chamber as it was uncovered and died because of injuries sustained by him because of that fall. Prima facie case of negligence in protecting human rights is reflected from the newspaper reporting. Hence the order:

- a) Issue notice of proceeding and call report of fact finding inquiry from the Commissioner, Kalyan Dombivili Municipal Corporation and the Managing Director, Maharashtra

Industrial Development Corporation, Mumbai within a period of eight weeks.

- b) Matter to appear on board before Court No.1 on 23rd September 2025 at 11.00 a.m.
- c) Inform the date of hearing to all concerned.

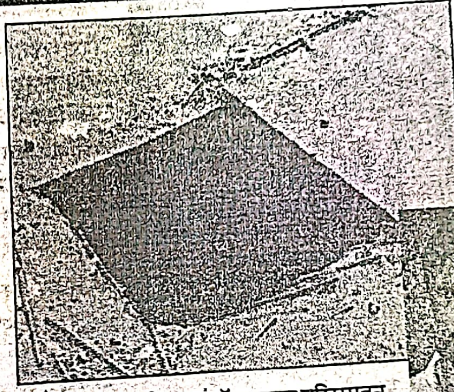

प्रशासनाच्या निगरगट्ट कारभाराचा बळी | कल्याण डॉ.बिवलीमध्ये संताप

डॉ.बिवली, दि. २१ (प्रतिनिधी) - कल्याण, डॉ.बिवलीत अर्धवट विकासकामे आणि खड्ड्यात गेलेल्या रस्त्यांमुळे नागरिक मेटाकुटीला आले आहेत. त्यातच आता नागरी सोयीसुविधांचाही बोजवारा उडाला असून एमआयडीसीच्या उघड्या चेंबरमध्ये कोसळून एका वृद्धाचा हकनाक मृत्यू झाला आहे. बाबू चव्हाण (६०) असे मृताचे नाव आहे. महापालिका आणि एमआयडीसीमध्ये समन्वय नसल्यामुळेच प्रशासनाच्या निगरगट्ट कारभाराचा हा बळी असल्याचा संताप कल्याण, डॉ.बिवलीत व्यक्त होत आहे. कल्याण पूर्वेकडील टाटा पॉवर नाका परिसरात आज दुपारी ही घटना घडली.

पाय घसरला आणि ते रस्त्यालगत असलेल्या एमआयडीसीच्या उघड्या चेंबरमध्ये पडले. चेंबरमध्ये कोसळताच त्यांच्या डोक्याला पाण्याच्या लोखंडी व्हॉल्वचा फटका बसला. परिसरातील नागरिकांनी घाब घेत त्यांना तातडीने चेंबरमधून बाहेर काढले. गंभीर जखमी अवस्थेतील चव्हाण यांना डॉ.बिवलीतील एका खासगी रुग्णालयात उपचारासाठी दाखल केले. मात्र उपचार सुरू असताना त्यांचा मृत्यू झाला.
