
You are further directed to submit your response in writing with relevant documents upon which you intend to rely in respect of your defence.

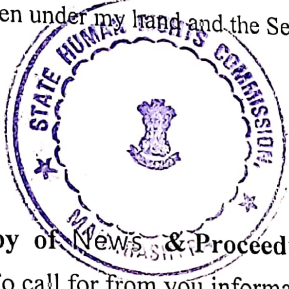

PROCEEDING

1. Perusal of the video clip which is viral on the You Tube platform shows that mentally retarded child in Mandki Village of District Chhatrapati Sambhaji Nagar is being brutally assaulted in the Ashram Shala named as Chaitanya Kanifnath Niwasi Matimand Mulanche Ashram Shala. Commission of cognizable offence is prima facie disclosed by the custodian of the child in the Ashram Shala. As case of violation of human rights of children in the Ashram Shala is prima facie made out, taking suo moto cognizance of such video clip, hence, following order:

a) Issue notice to the Secretary, Persons with Disability Welfare Department, Mantralaya, Mumbai as well as



Collector, Chhatrapati Sambhaji Nagar calling there action taking report in the matter.

- b) Similarly, issue notice to the Commissioner of Police, Chhatrapati Sambhaji Nagar and Superintendent of Police, Chhatrapati Sambhaji Nagar with a direction to file action taken report in the matter.
- c) Report to be filed in four weeks.
- d) Office is directed to forward the copy of the video clip to all concerned.
- e) **Matter to appear on board before Court No.1 on 22nd December 2025 at 11.00 a.m.**
- f) Inform to all the parties concerned.
